1. POLICY PRINCIPLE

Subject to annual budget adoptions, the financial contribution provided by Council to prescribed local town management committees are paid subject to receipt of each committee's:

- Audited Annual Financial Statement for the previous year;
- Acquittal report of any contributions within the previous year;
- A current copy of the relevant strategic or action plan;
- Details of achievements gained for the year and future goals for the ensuing year/s. This will enable an information report to be provided to Council.
